Dear Applicant,

We are happy to send you this application for scholarship assistance to the Jordan Schnitzer Family Art Adventures Program this coming season. Art Adventures offers spring break and summer art camps, teen workshops and many other art classes. These camps and classes bring together a diverse community of children for arts and crafts activities on OCAC's lovely ten-acre campus. We are looking forward to meeting another group of energetic, creative and enthusiastic children this season.

Scholarships are awarded to those students who have financial need; show strong creative characteristics and leadership ability, and whose strengths will add to the class/camp dynamic. Art Adventures cannot meet the full needs of all applicants. Financial aid is probably not possible for families whose adjusted income is more than \$50,000. However, we do consider the number of children in the family and the individual circumstances of each family. The more you can help us understand your circumstances, the better a decision we can make. Campers who qualify for a scholarship may reapply each year for up to three years.

To apply for scholarship, you will need to:

1. Complete the enclosed ART ADVENTURES SCHOLARSHIP APPLICATION FORM- including signing the ART ADVENTURES POLICIES page (which includes a Waiver of Liability) and completing the ART ADVENTURES AND PRE-COLLEGE MEDICAL RELEASE FORM.
2. Include a copy of your most recent IRS 1040 or verification of receiving public assistance (free lunch program, Oregon Health Plan, food stamps, unemployment pay stubs, etc.). Additionally, if you wish to provide any further information about your financial status that you feel would be helpful in determining your scholarship need it may be enclosed as a separate letter.
3. Send one letter of recommendation for the student from a teacher, employer, youth leader, coach, or spiritual leader. (No friends or family, please.)
4. Have your child write (or dictate) a paragraph stating why they want to attend Art Adventures.
5. Send all above items together by mail so it is received at the College as soon as possible.

Scholarship is given to those who qualify on a first come first served basis until the funds are depleted. Scholarship applications must be mailed or hand delivered; no faxed applications will be accepted. Please note, we have a three year limit to receiving a scholarship.

All financial information is strictly confidential. You will be notified within three weeks of your submission as to whether a scholarship will be awarded. Due to the amount of scholarship requests and financial need, Art Adventures is unable to grant scholarships for multiple sessions. Please apply for one session per student.

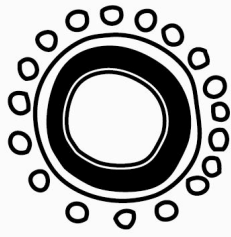

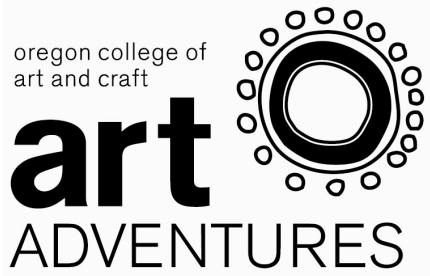

ART ADVENTURES POLICIES

Jordan Schnitzer Family Art Adventures Program scholarship recipients and their families must agree to and abide by all stated Art Adventures policies. Scholarship awards are for tuition costs only, with additional costs such as lunch and Before/After care service being the sole responsibility of the parent(s)/guardian(s).

CANCELLING A SCHOLARSHIP REGISTRATION

OCAC request that scholarship recipients that wish to cancel their registration do so at least two weeks prior to the beginning of a camp/course. This allows the college to potentially serve other applicant families. Cancellations must be made to the Community Programs Registrar in writing via email or mail. As awards are issued for specific courses/camp sessions based upon the scholarship application completed by parent(s)/guardian(s) OCAC cannot process requests for alternate courses/camp sessions after an initial award has been made.

YOUTH AND YOUNG ADULT (YA!) CAMP INFORMATION

ALL CAMPER MUST BE SIGNED IN AND OUT DAILY BY A PARENT/GUARDIAN OR AN ADULT APPOINTED BY THE PARENT/GUARDIAN. Children arriving at camp who are not signed in by an adult will not be able to join their group or their arts workshops until a parent/guardian (or appointed adult representative) signs them in. Two simple snacks and all art materials are provided in the tuition cost, but parent(s)/guardian(s) are responsible for providing a non-perishable sack lunch daily.

During Art Adventures camp sessions OCAC provides supervised Beforecare and Aftercare for an additional fee. Beforecare runs from 8:00am-9:00am and Aftercare runs from 5:00pm-6:00pm. No person under the age of 15 years may wait unsupervised on the campus of Oregon College of Art and Craft. Families may choose to have children 15 years or older enrolled in Beforecare and/or Aftercare.

INSERVICE COURSES

All YOUTH and YOUNG ADULT (YA!) programming occurring on INSERVICE days requires that participants be signed in and out daily by a parent/guardian or adult appointed by the parent/guardian. Snacks are provided during courses occurring on designated INSERVICE days, but all participants are required to bring a non-perishable sack lunch.

During Art Adventures courses occurring on INSERVICE days OCAC provides supervised Beforecare and Aftercare for an additional fee. Beforecare runs from 8:00am-9:00am and Aftercare runs from 4:00pm-5:00pm. No person under the age of 15 years may wait unsupervised on the campus of Oregon College of Art and Craft. Families may choose to have children 15 years or older enrolled in Beforecare and/or Aftercare.

PRE-COLLEGE INFORMATION (GRADES 9-12)

PRE-COLLEGE course participants may be provided with a list of additional, or recommended, supplies at the first class meeting. PRE-COLLEGE students are expected to abide by all rules governing the campus and its constituents. Completion of the registration and/or scholarship application form constitutes an understanding by the parent(s)/legal guardian(s) of the registrant that OCAC and its directors, officers, employees, volunteers, and agents are not responsible for monitoring PRE-COLLEGE registrants during meal times, snacks, breaks, or the hours preceding or following the instructional hours.

ART ADVENTURES WAIVER

Should any injuries occur during or as a result of my child's participation in any class or workshop, I/we the parent(s)/guardian(s) agree to indemnify and hold harmless Oregon College of Art and Craft and all directors, officers, employees, volunteers and agents connected with OCAC.
